



### **School Workforce Privacy Notice – General Data Protection Regulations**

We, Oak Multi Academy Trust trading as Overdale Junior School, are a data controller for the purposes of the General Data Protection Regulations (GDPR). This privacy notice explains how we use any personal information we collect about you.

#### **What information we collect about you?**

We process personal data relating to those we employ to work at, or otherwise engage to work at our trust. This information includes:

- Personal information (such as name, National Insurance number and address)
- Characteristics (such as ethnicity, employment contracts, remuneration details qualifications and absence details)

#### **Who we share information with and why We are required, by law, to pass on some of this personal data to:**

- our local authority
- the Department for Education (DfE)

We will not share information about you with third parties without your consent unless the law allows us to.

#### **We share information to comply with statutory, regulatory and contractual obligations. These may include, but are not limited to:**

- improving the management of workforce data across the sector
- enabling development of a comprehensive picture of the workforce and how it is deployed
- pay salaries and pension contributions
- informing the development of recruitment and retention policies
- allowing better financial modelling and planning
- enabling ethnicity and disability monitoring
- supporting the work of the School Teachers' Review Body
- comply with guidance such as 'Working Together' and safeguarding obligations
